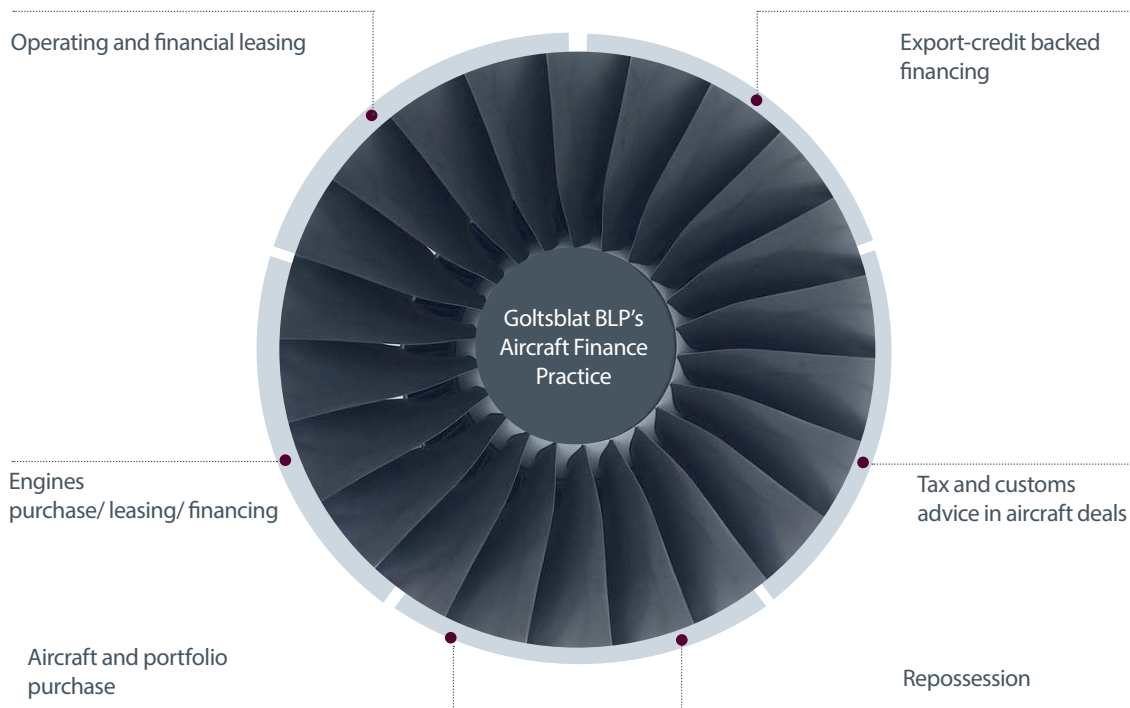

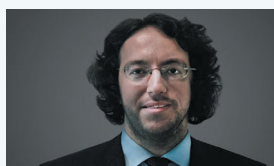

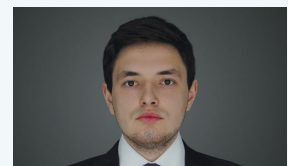

ICBC Financial Leasing
